# DATA CENTER HIGHLIGHTS

- Located less than two hours from New York City and Philadelphia. Additionally, seven different TierPoint data centers are within I50 miles
- Standalone, purpose-built, bored-to-bedrock foundation on a I37-acre, highly elevated campus
- Dual 69,000-volt utility source with 25MW total capacity
- Suspended walkways above the data center floor allow access to electrical and network equipment without interfering with client operations
- Fully redundant chiller plant including three 400-ton chillers with tertiary fail over to the central utility plant. Separate TierPoint infrastructure with two 650ton chiller expandable to 3,250 tons
- I2MW of N+I generator backup power
- Independent A/B UPS and internal power distribution systems, including distributed overhead busway, for optimal protection.
- Dark fiber and private I0Gb connectivity between facilities and to multiple, nationwide POPs via our gigabit Ethernet IP backbone

TierPoint's TEK - Allentown facility is audited under SSAE 18 SOC 2 Type II, PCI-DSS\*, GLBA and HIPAA standards annually, as well as ITAR and EU-US Privacy Shield registered.

PCI-DSS – Certification on PCI-DSS Requirement 9 & 12 (Physical Security and Information Security Policies) on data center (colocation) services. Colocation provides secure space, power, and environmental controls for merchants and service providers, some of which fall under PCI compliance. No logical access to any customer systems that may contain cardholder data.
